

**Independent Auditor's Review Report of the First Quarter and Three Months Ended of Silverpoint Infratech Limited pursuant to the Regulation 33 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, as amended**

**To the Board of Directors of Silverpoint Infratech Limited**

1. We have reviewed the accompanying Statement of Un-audited Financial Result ("Statement") of **Silverpoint Infratech Limited** ("the Company") for the first quarter and three months ended June 30, 2021, which are included in the accompanying "Statement of Un-audited Financial Results for the first quarter and three months June 30, 2021" together with the notes thereon (the "Statement"). The Statement has been prepared by the Company pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations, 2015"), which has been initialed by us for identification purposes.
